The Examining Board appoints in the first meeting Prof. Angeloantonio Russo as President. Dr. Riccardo De Blasis is appointed recording secretary of the meeting. The Examining Board meets at 1.20pm, December 2<sup>nd</sup>, 2021, in order to produce the final report.

#### MEETING no. 1

On November 19<sup>th</sup>, 2021, at 9.00 am, after having duly called the meeting on November 16<sup>th</sup>, 2021, the assembly of the Examining board committee for the additional admission competition to the international research doctorate in "Economics and Management of Sustainability and Innovation" - XXXVII cycle – academic year 2021-2022 takes place on computer-base.

Therefore, in attendance:

Prof. Angeloantonio Russo, Prof. Filippo Vitolla, Prof. Giustina Secundo, Prof. Domenico Morrone and Dr. Riccardo De Blasis. The Examining board appoints Prof. Angeloantonio Russo as Chairman. Dr. Riccardo De Blasis is appointed recording Secretary of the meeting.

Then the Examining Board Committee reads the announcement and sets the following criteria in order to evaluate the qualifications and research projects submitted by the candidates. Based on

the declaration in article 6 of the call for applications, the Examining Board sets the following detailed evaluation criteria, with specific regard to the assessment of curriculum vitae, qualifications, reference letters and research projects submitted by the candidates, as follows:

- Curriculum vitae and other qualifications (publications, degree awards, master on the subject of this PhD, etc.) and reference letters: a maximum of 20/100 points;
- Research projects: within the maximum score of 50/100 points for the research project set by the call for application, the Examining Board assesses the following aspects:
  - O Clarity and research attitude: are the objectives of the proposed project clearly explained? Is the project consistent with the green or innovation issues? Are the research questions consistent with the method? Is the proposed timeline consistent with the objectives? Does the research project address both theoretical and empirical issues? Are they consistent? Is the expected theoretical contribution clearly outlined? Are the research methods suitably described?
  - o Fit with the PhD program: the Examining Board assesses whether the research project fits well with the main topic related to the PhD program in Economics and Management of Sustainability and Innovation.

In order to carry out the above-mentioned evaluations the Examining Board will use, if possible, parameters recognized in the international scientific field.

The Chairman recalls to the other members of the Examining Board that the admission exam will consist of the evaluation of the qualifications and research projects, and of an oral exam.

Then, the Examining Board, according to art. 6 of the announcement, reaffirms as follows:

- In order to be admitted to the PhD Course the candidate must have a maximum score of 100/100 and a minimum score of 50/100.
- A sufficient evaluation by the Examining Board is synthesized as follows:
  - a) The maximum score for the qualifications and for the other documents submitted to the Examining Board's evaluation is 20/100.
  - b) The maximum score for the research project is 50/100.

c) The maximum score for the oral exam is 30/100.

The Examining Board set the cut-off level to be admitted to the oral exam in a minimum score of 35/100, as an average minimum score for the above points a) and b).

Last, the Examining board declares that there are no parental relationships, within the fourth degree among the members of the Examining Board. Moreover, they declare that there are no situations of incompatibility among them according to art. 51 and 52 of the civil procedure code.

As last fulfillment, the Examining Board sets the oral exam on December 2nd, 2021 with the following specifications as by the call for applications:

- An oral exam will take place at LUM University.
- An oral exam for candidates, who have submitted specific requests as in the call for applications, that is no later than the deadline of the call for application (art. 5), will take place through online systems. Those candidates, if admitted to the oral exam, have to send an email to Mariateresa Santaloia (santaloia@lum.it) no later than November 26<sup>th</sup>, 2021 in order to confirm their availability to attend the oral exam.

The Minutes 1 and the results of the evaluation of the qualifications and research projects for each candidate will be affixed on the door of the PhD Administrative Staff at the Rettorato building and published on LUM web site.

At 09.15 am the Examining Board declares the meeting closed and calls a further meeting on November 19<sup>th</sup>, 09.20 am to proceed with the assessment of qualifications and research projects. 
