Robotic Process Automation (RPA) is able to enable organizations to automate repetitive, rule- and activity-based processes to streamline processes, improve operational efficiency and reduce costs, all with unparalleled precision. From the perspective of technologies serving Smart Cities, RPA is able to influence the processes of defining and optimizing the services that Local Public Administration provides to its community by automating certain endoprocedures so that they become self-consistent and self-assisted.

RPA puts robots at the service of the relevant municipal structure and provides a better, faster and seamless experience for its residents, staff or guests.

Further scope is given by the continuous monitoring of the perfomances and KPIs of the services offered by Smart Cities, which enables improved service delivery by the public sector.

Consistent with the department's scope of action, the research track intends to focus

- on the security aspect inherent to the agents and robots that are processed and handled in the automation of PAL processes, an aspect of a crucial importance given the criticality of the scope and consistency of the data itself handled;
- on aspects related to regulatory compliance for data use according to the principles of privacy, interoperability and portability.





The activities carried out will be multidisciplinary in nature and will provide new analyses and methods to expand the current state of the art.

## Research Subject (description):

The objective of the research track is to define and implement an innovative and interdisciplinary data analytics model that supports decision-making processes and complies with regulatory constraints, such as the EU Regulation 2016/679 (GDPR).

Specifically, the planned research activities will cover:

Firm: ZeroDD S.c.a r.l.

- (State of the art analysis regarding current data analytics models, delving into the specific steps of their processes.
- In-depth analysis of the EU Regulation 2016/679
- State of the art analysis with respect to data analysis tools and the use of machine learning methodologies.
- Evaluation of the strengths and problems of the analyzed process steps in order to highlight their potential for improvement.
- Analysis of risks due to alteration, unavailability, and breach of personal data (economic, legal, reputational, penalty, and compensation impacts)
- Definition of the process of data extraction, transformation and loading into a summary system (data warehouse, data mart, big data etc.).
- Strategy for defining KPIs useful for optimizing data analysis.
- Definition of a real use case with the design and implementation of a data analysis dashboard.
- Definition of an additional layer of machine learning to make the dashboard more "active" (it will be the dashboard that "invites" the





user to view certain data, which according to artificial intelligence may be more interesting).

• Formalization of regulatory constraints within the optimization processes and algorithms.

The interdisciplinary nature of the activities carried out will provide new approaches to data analysis and define methodologies that deepen and expand the current state of the art, overcoming the traditional silo logic of scientific knowledge.

## Art. 3 - Admission requirements

- 1. The admittance to the selection process is reserved to the Italian and foreigner candidates, who holds the following degrees: New regulations: Master of Science in Law (class LMG/01) Special degree in Law (Class 22/s), Special degree in business economics sciences (class 84/s), Master of sciences in business economics sciences (class LM77) Master of science in Juricial sciences (LM SC-GIUR) or Old regulations: Law; Economics and Commerce taken in Italy or in any foreigner university recognized as equivalent to an Italian one.
- 2. Those candidates, who hold a degree of a foreign University, recognized as equivalent to one of the above mentioned degrees and awarded by Italian Universities, must apply for the declaration of equivalence from the Examining Board to the sole end of admittance to the competition of the Research Doctorate and must enclose to the application form the module compiled with the kind of degree, the final mark and the list of exams with the evaluations translated in Italian or English following what is foreseen by art. 3.

For the sole purpose of admission to the doctoral program, the suitability of the degree is evaluated by the Examination Board with subsequent declaration of equivalence by the University.

The Italian candidates who get the degree within the 30/09/2022 can participate to the admission exam. They will be admitted "with reserve" and they will be excluded from the pass-list if they will not get the degree within that date.





# Art. 4 - Presentation of the admission applications

The application form, drawn up according to the facsimile attached to the present announcement, available on, <a href="https://www.lum.it/dottorati-ricerca-giurisprudenza/">https://www.lum.it/dottorati-ricerca-giurisprudenza/</a> must be filled in, signed, scanned and sent in advance together with all the other required documents, in digital format (PDF or similar), <a href="mailto:withinseptember 1st 2022">withinseptember 1st 2022</a> to Dr. Mariateresa Santaloia (<a href="mailto:santaloia@lum.it">santaloia@lum.it</a>), who will send a reply to the same e-mail address certifying the receipt, attaching the scanned registered copy. The application could be even sent to this pec address <a href="mailto:concorsilum@pec.it">concorsilum@pec.it</a>.

In the title of the e-mail it is necessary to quote: "Admission competition to the PhD Program in the General Theory of the process – XXXVII cycle".

If the candidate cannot deliver the original application according to the above mentioned rules, or if the documents are different from those that are delivered by mail, the candidate will be excluded from the selection.

The candidates are expected to pay a contribution of € 55.00, as entrance examination fee, by bank transfer, to the following current account:

This amount is not returnable in any case.





In case of non-delivery of original documents within the above deadlines, or discrepancies between the documents sent by email and those delivered in original format, the candidate will be excluded from the PhD admission competition.

Candidates will not be admitted unless they have declared under their own responsibility, the following information on their application form:

- a) their surname and name, date and place of birth, tax code, citizenship, place of residence, contact address chosen at the aims of the selection process, including post code, telephone number and e-mail address;
- b) Curriculum vitae et studiorum duly signed in the forms provided for by D.P.R. 445/2000;
- c) their degree, specifying when (date) and where (University) it was awarded, or equivalent degree obtained abroad. Those who hold a degree, obtained in a foreign University, which hasn't been recognized as equivalent to one of the above mentioned degrees awarded by Italian Universities, must ask for the declaration of equivalence with the sole end of admittance to the competition for the Research Doctorate. To this end, it is necessary to enclose the translated and legalised degree certification containing certified transcripts of records of all examinations taken by the candidates and their study plan. Furthermore, candidates should enclose any other documents, translated and legalised, that they consider useful for the above-mentioned declaration of equivalence (Annex 1).
- d) List of the qualifications and of the publications they wants to be evaluated duly signed in the forms provided for by D.P.R. 445/2000;
- e) a commitment to attend the Doctoral course full-time, at all the partner Universities, in accordance with the procedures set out by the Teaching Staff Council.
- f) their level of knowledge of the English language and of any other foreign languages (satisfactory, good, excellent)
- g) a commitment to communicate information about any change of residence or contact address chosen for the selection process
- h) the indication of the scientific-disciplinary sector in which they want to hold the entrance examination
- i) The research project drawn up according to the directions in Article 2 for those who intend to participate for one of the two positions with Fellowship co-funded by the companies mentioned in paragraphs b and c of Article 1
- j) copy of the contribution of € 55,00 as entrance examination fee





I) copy of an identification document, duly signed.

People who have disabilities should specify on the application form, according to current regulations, any aid they require and/or any request for additional time to complete the selection examination.

To the application form the candidates must even enclose the documents and the publications of item d).

The University Administration will accept no liability for communication problems due to candidates providing inaccurate details of their residence or contact address, or to any delay in their notifying the Administration of any changes to said details, or to failings of the postal or telegraphic or telematics services beyond the Administration's control.

#### Art. 5 - Exclusions

The University administration can make in any moment, till the decree of appointment of the winners, the exclusion form the competition because of lack of the admission requirements.

The clearly justified exclusion will be done by Presidential decree.

The candidates that declare something not true in the application form will forfeit the right to participate to the entrance admission.

### Art. 6 - Selection

The aim of the entrance examination is to assess the candidates' aptitude for scientific research and the knowledge of the language chosen in the admittance form.

The examining board has a maximum score of 100/100 for the evaluation of the publications and of the entrance examinations.

The maximum score for the qualifications and for the other documents submitted to the Examining Board's evaluation is 10/100.

The maximum score for the written exam is 60/100 and that for the oral exam is 30/100.





The minimum score for the written exam in order to pass at the following exams is 36/100. The minimum score for the oral exam is 18/100

The minimum score to pass the entrance examination is 60/100.

The evaluation and the criteria for the marks to be given to the qualifications and to the other documents submitted to the evaluation will be published by the Examining Board out of the room of the exam before the oral exams.

The written exam will be in Italian. The candidate can choose to hold the oral exam in Italian or in one of the two language that he has chosen in the application form.

Candidates will be notified of the date of the oral test by the Selection Committee on the day the written test is held. There are no notice periods between the written test and the interview.

Written notice of the date, time and place of the exam will be communicated on the webpage <a href="https://www.lum.it/teoria-generale-del-processo/">https://www.lum.it/teoria-generale-del-processo/</a> on the Doctorate section without any other advice.

Candidates who are absent on the day of the entrance examination, for whatever reason, will be deemed to have withdrawn their application.

## **Art. 7 - Examining Board**

The Examining Board will be composed of 5 effective members, and of 5 substitutes appointed among the full professors, associate professors and researchers of the Università LUM Giuseppe Degennaro of Casamassima (BA) and among the other professors of the Teaching Staff council. The substitutes will replace one or more effective members in case of impediment. To the examining Board could even participate up to two advisers belonging to private or public research centres (even foreigner ones).

Before the entrance examination, the Examination Board will decide the criteria for the marks to be given to the publications and to the other documents submitted to the evaluation and will publish them out of the room of the exam and on the Rectorship Secretariat – PhD office.

The evaluation of the publications will be affixed before the oral exam out of the room of the exam and on the Rectorship Secretariat – PhD office. The





examining Board will affix out of the exam room and on the Rectorship Secretariat – PhD office the results of the exams.

The general merit-based ranking will be approved by Chairman's Decree and published on the notice board of the Università LUM Giuseppe Degennaro – S.S. 100 Km. 18, CAP 70010 Casamassima – (Bari)- Italia and on the website of the above mentioned University.

To the admitted candidates will be sending a communication by registered letter or with other means able to guarantee the receipt, even by webmail.

### Art. 8 - Admission

Candidates will be admitted to the Doctorate Course according to the ranking list and up to the number of available places established for the Doctorate. In cases of equal merit, precedence will be given to the youngest candidate. The admitted candidates will be excluded if their acceptance is not received within 10 days of the communication of the results of the entrance examination.

Special rankings will be prepared for the posts with fellowships referred to in subparagraphs b and c of Article 1 regarding the candidates who have submitted and discussed the research project referred to in subparagraph i of the application. The provisions of the first paragraph shall apply to the extent of compatibility.

If a successful candidate forfeits his/her right to a position before the beginning of the course, the next candidate in the rankings will be offered the place, according to the ranking list order.

### Art. 9 – Awarding

Candidates who have been admitted must present their personal data and their application form for enrolment, in person or by mail, to the Administrative Office of this University, on plain, unstamped paper, for the attention of Dott.ssa Mariateresa Santaloia, within 10 days of the communication of the results of the entrance admission.





- a) self-declaration of citizenship;
- b) self-declaration of the University degree with official transcripts of records, of the date and of the University;
- c) declaration in which the candidate states that he/she has not enrolled on any University course and has no intention of doing so for the legal duration of the Doctorate course:
- d) declaration in which the candidate states that he/she has not enrolled on any Specializing Courses, and in cases where he/she has already done so the candidate agrees to suspend or interrupt the course before the Doctorate course begins;
- e) declaration in which the candidate states that he/she has not benefited from previous Doctorate scholarships;
- f) declaration in which the candidate states whether or not he/she is a State employee;
- g) Self- declaration (only for the scholarship winners) of the income regarding the year 2021;
- h) for those who are awarded scholarships financed pursuant to Ministerial Decree 351 and 352 of 2022 statement containing a commitment to repay the amount received if, for any reason, they do not obtain the degree of PhD.

All documents written in English must be translated and legalised by the appropriate qualified Italian diplomatic or consular representatives abroad and must comply with the rules in force in that State.

Candidates must enclose to their application form a photocopy of a valid identity document, duly signed, the payment of ADISU Tax, the payment of the contribution for insurance for third-party liability against damage, two passport-size photographs and even, for the winner without scholarship the payment of the annual fee as specified in the following art. 11.

# Art. 10 - Scholarships

Candidates admitted to the Doctorate Course according to the ranking list will benefit from the scholarships up to the number of scholarships available. In cases of equal merit, precedence will be given to the youngest candidate.





The annual amount of the scholarship is euro 20.083,00 gross of the charges to be borne by the University equal to euro 3.839,73 per year and of the social security charges for the amount paid by the student.

The scholarship won't be paid out in case the scholarship winner, in the year before the starting up of the Ph.D., has a taxable income of more than € 25.000 (twenty-five thousand) euros.

The scholarship will be 50% higher than the annual scholarship for research periods abroad (as provided by Italian Law). Scholarships are paid every month, ex post.

Scholarships are confirmed for the following Academic Year if the Teaching Staff Council validates the results achieved by the PhD students and their income. Scholarships cannot be combined with other scholarships awarded for the same purpose. Those who benefited from a Doctorate scholarship, even for only one year, cannot benefit from a further scholarship.

The scholarships are incompatible – under penalty of forfeiture of the grantee from the enjoyment of the grant itself from the occurrence of the incompatibility – with:

- subordinate employment with a ended of open ended contract in private of public enterprises, except if the employer puts him on leave without contributions;
- Commerce or industry activities;
- Working contracts with Public authorities as foreseen by article 7 item
- 6 of D.lgs. 30 March 2001, n. 165;
- Collaboration contracts as foreseen by article 61 item 1 of D.lgs. 10
- September 2003, n. 276.

#### Art.11 - Enrolment fee

When they enrol, Scholarship winners are expected to pay a contribution of 50 Euros towards the annual insurance for third-party liability against damage, as well as stamp duty for the application on the following current account:

**Doctorate students (who have not win the scholarship)** are expected to pay a contribution of € 4.250,00 per annum. The contribution must be paid, by Bank transfer on the following current account:

Moreover all the PhD students have to pay the Regional Tax for the Right to study according to art. 11 of regional law nr. 45/2012. More information will be given in the enrolment form.

## Art.12 - Ph.D. students' duties

Enrolled students must attend the Doctorate courses held in the University, in accordance with the procedures established by the Teaching Staff Council and must carry out their research studies and activities regularly within the structures intended for that specific aim, in accordance with the procedures established by the Teaching Staff Council.

The admission to the PhD course implies an exclusive and full time engagement of 1.500 hours per year

The PhD students with scholarship and to Phd students who are employees on unpaid leave, must stay in the University's structures at least 4 days a week. The Phd students without scholarship are required to stay at University one days a week, witout prejudice to the obligation to attend lessons, seminars and meetings organized by the PhD. All the PhD students have to fill daily the "PhD student's Libretto" and to sign it, where he has to specify the hours and the activities he has done. They have not to stay in the University during the period of closure of the buildings and (if it do not coincide) during the annual periods of rest. This disposal is applied compatibly with what is established in the regulation, which disciplines the jointed frequency between the PhD program and the Medicine specialization schools, and even according to which is established by the conventions with the enterprises in case of industrial curricula in cooperation with them. The "PhD student's Libretto" is deposited in the "PhD Office".

The PhD student is required to make a detailed semi-annual Report of the activities performed, whether classroom or individual research. The said Semi-





annual Report must be countersigned by the doctoral student's Tutor and filed with the "Doctoral Office" of the University at the disposal of the Board of Teachers and the Coordinator.

The PhD student, in its training project, can make, after clearance of the TSC and advice of the Didactic structures, without any increase of the PhD scholarship, activities of tutoring for the students of degree and Msc, and even, maximum 40 hours of integrative teaching for each academic year.

The public employees admitted to the PhD program can have for all the period of the program the expectation foreseen by their contracts. The expectation for the employees under public law, of extraordinary leave for educational purposes in order to study, is granted if it is compatible with the requirements of the public office by which he/she is employed, according with article 2 of the Law 13 August 1984, nr. 476, and subsequent amendments and integrations, with or without salary and unless there is an expressed claims waiver only if they are enrolled for the first time to a PhD Program, regardless the kind of program.

The interventions foreseen by the Leg. Decree nr. 68 of 29.03.2012 are extended to the PhD students.

The female PhD students are protected during their pregnancy as foreseen by the Decree of the Minister of Labour 12.07.2007, published on Official Journal nr. 247 of 23.10.2007.

The attendance of the PhD program can be suspended, after decision of TSC, for at maximum one year maintaining the right to have the scholarship, except the interruption of the payment of it, that will be payed after the PhD student will start to attend the PhD program again. It will arrive only in case of Pregnancy, military service or Civil service and severe and documented illness; as well as for similar cases not expressly mentioned in Article 8 of the General Regulations for Doctoral Programs and in all cases in which the College considers that suspension of attendance meets the doctoral student's educational and research needs, and does not conflict with the purposes of the Doctoral Program.

The PhD student cannot attend in the same time a Specialization school or a Degree. If the winner is enrolled to a Specialization school or to a Degree he





has to suspend to attend those courses before the beginning of the PhD program.

The PhD students who attend the TFA (Active Traineeship) or to Masters or Specialization Course can obtain to freeze the beginning of the PhD program for at maximum 3 months. This period can be recovered within the legal duration of the PhD program according with the advice of the TSC.

If this period will be longer that 3 months, and no longer that one year, the activities of that PhD program must be deferred.

The TSC can propose with a motivated decision, after having listened the PhD student, that he can be temporarily suspended by the program, or to be excluded by it with the consequent total or partial loss of his scholarship in case of:

- negative assessment by the Teaching Staff Council of the results achieved during the academic year;
- overcoming of the maximum number of absence as it is allowed by each PhD program regulation;
- unjustified and prolonged absences;
- behaviours in contrast with the rules of incompatibility.

In the aforementioned cases, the scholarship will be suspended and the scholarship holder will be obliged to pay back all sums received during the year to which the disciplinary action relates.

### Art. 13 - Evaluation of research activities

At the end of each year of the course, according with internal PhD program regulation, the TSC decides with the absolute majority, the admission to the following year of the program and/or to the final exam or, eventually the exclusion of the student, evaluating his assiduity, its profits and the progress of each PhD student, even as regards the number of publications for each year of the program. His evaluation it is made with the presentation of the two sixmonthly reports of the previous year which the PhD student has filled and deposited by him at the "PhD Office". The TSC can eventually decide to listen the PhD student. The Student who will not pass that exam can be admitted under condition to fill the gap within three-months of the following year.





## Art. 14 - Ph.D. degree

The Ph.D. Degree, awarded by the Rector and by the Chairman of Università LUM Giuseppe Degennaro, will be obtained following successful completion of the final examination, which will show the achievement of high scientific value results through the presentation of a written thesis in accordance with art. 8 of the "University Regulations on Research Doctorates".

For the final examination, on the advice of the Teaching Staff Council, the Rector will appoint a special Examining Board, in accordance with "University Regulations on Research Doctorates"

## Art. 15 - Processing of Personal Data

With reference to the provisions of Reg. UE679 / 2016, concerning the protection of persons and other subjects with regard to the processing and dissemination of personal data, Dr. Mariateresa Santaloia, as owner of the data relating to this competition, informs that the processing of the data contained in the competition applications is aimed solely at the management of the competition activity and that the same will take place with the use of IT procedures and paper filing of the related documents.
